## #Note on IPCL Claim-

INR 1,28,20,16,594 of the admitted claims pertaining IPCL are contingent upon the outcome of the proceedings ongoing at the National Company Law Tribunal, Hyderabad Bench, in relation to the conversion of such amounts into equity shares of the Corporate Debtor.

The claim amount rejected pertains to claim for the equity holding in Meenakshi Energy Limited. As equity does not form part of Financial Debt as per Section 5 (8) of the Insolvency and Bankruptcy Code, 2016, ('IBC') the amount has been rejected.

IPCL has been admitted as a Financial Creditor Related Party as per Section 5 (24) of IBC and basis the provisions of Section 21 of IBC a Financial Creditor Related Party shall not have any right of representation, participation or voting in a meeting of the committee of creditors.

## \*Note on claim by Mr. Devineni Suresh-

Meenakshi Energy Limited (MEL) had availed a loan amounting up to INR 209 Crores inter alia from Punjab National Bank ("PNB") as per the terms set out in the working capital consortium agreement dated September 18, 2012 ("Consortium Agreement"). The loan under the Consortium Agreement was guaranteed by a personal guarantee by Mr. D. Suresh ("Personal Guarantor") dated September 18, 2012 ("Personal Guarantee"). MEL defaulted in its payment obligations towards the lenders under the Consortium Agreement. Accordingly, PNB filed a suit for recovery before the Hon'ble Debts Recovery Tribunal II ("DRT II") bearing reference number O.A.No. 514/2019 inter alia against MEL and the Personal Guarantor. In its petition PNB has prayed that MEL and the Personal Guarantor are jointly and severally liable to pay an amount of INR 37,06,51,724. together with subsequent interest to PNB. However, the matter is currently pending and no order has been passed by the DRT II and no payment has been made by the Personal Guarantor to PNB. Accordingly, following the decision of Hon'ble NCLAT in the in the case of Neeraj Bhatia vs. Davinder Ahluwalia and Ors. Bearing reference number Company Appeal (AT) (Insolvency) No. 142 of 2017 the Personal Guarantor's claim as financial creditor has not been admitted.

## Notes:

1. Out of the total claim admitted, INR 179,45,00,000/- is towards relinquishment charges as LTA as per BPTA Dtd 24.12.2010 signed by MEL was relinquished in line with CERC Order dated 28.02.2019 in Petition No. 296/MP/2018 with liability to pay relinquishment charge and charges were levied in line with CERC (Central Electricity Regulatory Commission) Order in Petition No. 92/MP/2015 dated 08.03.2019 ("Order dated 08.03.2019"). MEL has appealed the CERC order dated 08.03.2019 before APTEL challenging the principles and computational methodologies prescribed by the Hon'ble Commission and accordingly, the admitted claim is contingent to the outcome of the Appeal proceedings.
2. The arbitrator had given an award on 29-04-2020 in the arbitral claim of the Operational Creditor to the tune of INR 13,96,19,776 + simple interest @ 7.5% p.a. w.e.f. 01.07.2018 till date of payment. The amount admitted is INR
